- Referrals: Aetna Medicare UnityPoint Health Prime (HMO) doesn't require a referral from a PCP to see a specialist. Keep in mind, some providers may require a recommendation or treatment plan from your doctor in order to see you.
- Network: Our plan has joined with UnityPoint Health Methodist Proctor to provide you with patient-centered care. You must utilize these network providers for your medical care. To locate a network provider you may contact Member Services or search the online provider directory.
- Prior authorizations: Your provider will work with us to get approval before you receive certain services or drugs. Benefits that may require a prior authorization are listed with an asterisk (*) in the benefits grid.
