## What you should know

- **Primary Care Physician (PCP):** A PCP is important for helping to coordinate care and this plan requires you to select a PCP. When you enroll, we’ll ask who your PCP is. If you don’t tell us, we’ll assign one to you. You can always change the PCP by calling us or logging into your member portal.
- **Referrals:** Aetna Medicare Advantra Eagle (HMO) doesn’t require a referral from a PCP to see a specialist. Keep in mind, some providers may require a recommendation or treatment plan from your doctor in order to see you.
- **Prior authorizations:** Your provider will work with us to get approval before you receive certain services. Benefits that may require a prior authorization are listed with an asterisk (\*) in the benefits grid.

If you are diagnosed with one or more of the conditions listed in the EOC and meet certain criteria, you may be eligible for additional benefits under our plan. Member eligibility will be determined through medical claims submission. Provider submitted medical claims with a diagnosis supporting the conditions listed in the EOC will qualify you for eligibility.

**Healthy Foods:**

You will receive a preloaded debit card in the mail with a \$150 quarterly allowance. Benefit can be used towards the purchase of healthy and nutritious foods and produce at approved retail locations, as well as online and over the phone.
