If you are diagnosed with one or more of the conditions listed in the EOC and meet certain criteria, you may be eligible for additional benefits under our plan. Member eligibility will be determined through medical claims submission. Provider submitted medical claims with a diagnosis supporting the conditions listed in the EOC will qualify you for eligibility.

Fresh Food Boxes:

Our plan has contracted with FarmboxRx to assist you in maintaining a healthy diet and meeting your nutritional needs.

If you are eligible, you may receive fresh food and produce delivered directly to you. If you are eligible, you will receive a letter to let you know how to set up this benefit. You may schedule up to one fresh food box every two weeks.

If you believe that we have failed to provide these services or discriminated in another way on the basis of race, color, national origin, age, disability, or sex, you can file a grievance with our Grievance Department (write to the address listed in your Evidence of Coverage). You can also file a grievance by phone by calling the Customer Service phone number listed on your benefit ID card (TTY: 711). If you need help filing a grievance, call Customer Service Department at the phone number on your benefit ID card.
