# What you should know

- Plan type: Aetna Medicare Option 2 (HMO) is an HMO plan. This is a Medicare Advantage plan that covers prescription drugs.
- Primary Care Physician (PCP): A PCP is important to help coordinate your care. We require you to select a PCP. When you enroll, we'll ask who your PCP is. If you don't tell us, we'll assign one to you. You can change your PCP anytime by calling us or logging into your member portal.
- Referrals: Aetna Medicare Option 2 (HMO) doesn't require a referral from a PCP to see a specialist. Keep in mind, some providers may require a recommendation or treatment plan from your doctor in order to see you.
- · Prior authorizations: Your provider will work with us to get approval before you receive certain services or drugs.

There is no network, so you can see any dental provider licensed in the US or the US territories. #### **Medicare Part B drugs**

Your doctor often needs approval from us before we cover these services. This is called **prior authorization** or pre-certification.

# **Medicare Part D drugs**



Medicare Part D covers a wide range of prescription drugs. They can include medicines you take every day for conditions like high blood pressure or diabetes.

#### Prescription drugs (Your costs may be lower if you qualify for Extra Help)

Formulary name B4: Some drugs require **prior authorization**. This means you must get approval

from us first before we'll cover it.

#### **Deductible phase**

You'll pay the plan's negotiated drug cost up to the deductible limit.

This plan doesn't have a deductible, so your coverage \$0 begins at the Initial coverage phase.

#### **Initial coverage phase**

The plan will pay its share of the cost and you'll pay a copayment or coinsurance (your share of the cost) for each prescription filled until your total drug costs reach \$5,030. You pay the copay listed below or the cost of the drug, whichever is lower. These cost shares may also apply to home infusion drugs when obtained through your Part D benefit.

#### Over-the-counter (OTC) benefit

You will receive a \$90 benefit amount (allowance) each quarter to purchase approved over-the-counter (OTC) health and wellness items like first aid supplies, cold and allergy medicine, pain relievers, COVID-19 tests, and more. The \$90 benefit amount is available the first day of each calendar quarter. Calendar quarters begin in January, April, July, October. Be sure to use the full benefit amount each calendar quarter, because any unused amount will not roll over into the next calendar quarter.

We have partnered with OTC Health Solutions (OTCHS) to provide this benefit. The benefit amount is not connected to a payment or debit card. You will use your Aetna Medicare Option 2 (HMO) member ID to confirm benefit eligibility, confirm available benefit amount, and make purchases. Members may have the option to sign up for automated mail-order delivery.

If you have a Medigap plan, once your Medicare Advantage coverage starts, you may want to drop your Medigap policy because you will be paying for coverage you cannot use.
