- Be entitled to Medicare Part A
- Have Medicare Part B
- Live in the plan's service area, which includes the following counties: Pennsylvania: Bucks, Chester, Delaware, Montgomery, Philadelphia

What you should know

- Plan type: Aetna Medicare Advantra Value (HMO-POS) is an HMO plan. This is a Medicare Advantage plan that covers prescription drugs.
- **Primary Care Physician (PCP):** A PCP is important to help coordinate your care. We require you to select a PCP. When you enroll, we'll ask who your PCP is. If you don't tell us, we'll assign one to you. You can change your PCP anytime by calling us or logging into your member portal.
- Referrals: Aetna Medicare Advantra Value (HMO-POS) doesn't require a referral from a PCP to see a specialist. Keep in mind, some providers may require a recommendation or treatment plan from your doctor in order to see you.
- Prior authorizations: Your provider will work with us to get approval before you receive certain services or drugs.

Medicare Part B drugs

They can include things like vaccines, injections, and nebulizers, among others. They can also include medicines you take at home using special medical equipment. Your doctor often needs approval from us before we cover these services. This is called **prior authorization** or pre-certification.

Medicare Part D drugs



Medicare Part D covers a wide range of prescription drugs. They can include medicines you take every day for conditions like high blood pressure or diabetes.

Deductible phase

You'll pay the plan's negotiated drug cost up to the deductible limit.

The plan will pay its share of the cost and you'll pay a copayment or coinsurance (your share of the cost) for each prescription filled until your total drug costs reach \$5,030. The \$120 benefit amount is available the first day of each calendar quarter. Calendar quarters begin in January, April, July, October.
