Simply Level (HMO C-SNP) is a Medicare Advantage Special Needs Plan. It includes hospital, medical, and prescription drug benefits. To join this plan, the following must apply to you:

- You're entitled to Medicare Part A.
- You're enrolled in Medicare Part B.
- You're diagnosed with diabetes mellitus, a cardiovascular disorder, and/or chronic heart failure.
- You live in our service area.

You need to visit doctors and facilities in this plan's network. This is very important. If you go outside the network, the services may not be covered.

## Medicare coverage that goes beyond Original Medicare

- Medicare Advantage plans cover everything Original Medicare covers — Part A (hospital services) and Part B (medical services) — plus more.
- Medicare Advantage Prescription Drug Plans cover Medicare Part D drugs and Part B drugs.

## This is a Health Maintenance Organization Special Needs Plan (HMO SNP).

### That means:

- You must choose a primary care physician (PCP) in the plan's network of doctors for covered services. Your PCP provides most of your medical care, including routine care and hospitalizations. They can help you save time and money by directing you to specialists when needed.
- Before you visit a specialist, we recommend you talk to your PCP first. They know your health history and can help you find the right care.

## Is your PCP in our plan's network of doctors?

If you need to change your primary care physician (PCP), give us a call and we'll help. Doctors can join or leave the network at any time, so check if they're in-network with our Find a Doctor tool online. Just follow the steps below.

Our plan has a lifetime limit of 190 days for inpatient mental health care in a psychiatric hospital. This limit does not apply to inpatient mental health services provided in a general hospital.

Our plan covers 90 days for an inpatient hospital stay.

Our plan also covers 60 "lifetime reserve days." These are "extra" days that we cover. If your hospital stay is longer than 90 days, you can use these extra days. Once you have used up these extra 60 days, your inpatient hospital coverage will be limited to 90 days.

Our plan covers up to 100 days in a Skilled Nursing Facility (SNF).

Your copays for SNF benefits are based on benefit periods. A benefit period starts on the first day you go into a hospital or SNF and ends when you haven't had any inpatient hospital care or skilled nursing care for 60 days in a row. If you go into a SNF after one benefit period has ended, a new benefit period starts. There's no limit to the number of benefit periods you can have.

- Some prescription vitamins, such as folic acid and Vitamin D 50000 IU.

This benefit provides a **\$1,000.00** annual spending allowance for your dental, vision, and/or hearing needs. You get to choose how to use your annual spending allowance - toward out-of-pocket costs or additional services.

### Everyday Options Allowance for Groceries, Home and Pet Care Supplies, and Utilities

If you have a diagnosed chronic condition, this benefit provides a combined spending allowance of **\$50.00** each month for eligible food items, home and pet care supplies, and utilities.

 For Diagnostic Services, Labs, and Imaging with a 5, if there is a copay or coinsurance range, the minimum applies to doctor's offices and freestanding outpatient facilities. The maximum copay or coinsurance applies to a hospital facility as an outpatient service.

### Stage 1: How much is my deductible?

This plan does not have a Part D deductible.

### Stage 2: Initial Coverage

After you pay your yearly deductible (if your plan has one), you pay the amount listed in the table on the following pages, until your total yearly drug costs reach **\$5,030**. Total yearly drug costs are the total drug costs paid by both you and our Part D plan.

You may get your covered drugs at retail pharmacies and mail-order pharmacies in our plan. Generally, you may get your covered drugs from pharmacies not in our plan only when you are unable to get your prescription drugs from a pharmacy that is in our plan. If you live in a long-term care facility, you pay the same as at a standard retail pharmacy.

If you qualify for low-income subsidy (LIS), also known as Medicare's Extra Help program, the amount you pay may be different in this Stage.

## Simply Level (HMO C-SNP)

### Stage 3: Coverage Gap

After your total yearly drug costs reach **\$5,030**, you will receive limited coverage by the plan on certain drugs. You will continue to pay your ICL cost share for Tier 1 preferred generic drugs, Tier 2 generic drugs and some Tier 3 preferred brand drugs in the coverage gap. You will pay no more than **25%** of the plan's costs for other formulary brand and generic drugs until your yearly out-of-pocket drug costs reach **\$8,000**.

### Stage 4: Catastrophic Coverage

After your yearly out-of-pocket drug costs reach **\$8,000**, the plan will pay all of your Medicare covered Part D drug costs for the rest of the year.

# Our care teams work for you

If you have a chronic condition (diabetes, high blood pressure, heart failure, etc.) or major health issue, our case management team is here for you. This service is included at no extra cost.

**Case management** includes a team of trained nurses, social workers, therapists, and other medical specialists that can help you:

- Plan preventive care.
- Learn ways to manage your symptoms.
- Find community resources.
- Get referrals to other programs we offer.
- Plan for hospital stays or a procedure

**Discharge planning** includes a special inpatient team that works with your doctor, so you have the services you need after leaving the hospital.

If you need emergency or urgent care, call 911 or go to the nearest doctor or facility that can help you. Most times, you must use doctors in our plan to receive covered medical care, except for emergencies and urgently needed care when doctors in our plan are not available or dialysis services when you are out of the service area. If you receive routine care from doctors outside our plan, neither Medicare nor Simply Healthcare will pay for it.

Some benefits mentioned are a part of a special supplemental program for the chronically ill. Not all members qualify.

Simply Healthcare Plans, Inc. is an HMO C-SNP Medicare-contracted coordinated care plan that has a Medicaid contract with the State of Florida Agency for Health Care Administration to provide benefits or arrange for benefits to be provided to enrollees. Enrollment in Simply Healthcare Plans, Inc. depends on contract renewal.
