- ☐ You live in our service area.

You need to visit doctors and facilities in this plan's network. This is very important. If you go outside the network, the services may not be covered.

A benefit period begins the day you're admitted as an inpatient and ends when you haven't received any inpatient care (or skilled care in a SNF) for 60 days in a row. If you go into a hospital or a SNF after one benefit period has ended, a new benefit period begins.

Our plan covers 90 days for an inpatient hospital stay.

Our plan also covers 60 "lifetime reserve days." These are "extra" days that we cover. If your hospital stay is longer than 90 days, you can use these extra days. Once you have used up these extra 60 days, your inpatient hospital coverage will be limited to 90 days.

After you pay your yearly deductible (if your plan has one), you pay the amount listed in the table on the following pages, until your total yearly drug costs reach \$5,030. Total yearly drug costs are the total drug costs paid by both you and our Part D plan.

You may get your covered drugs at retail pharmacies and mail-order pharmacies in our plan. Generally, you may get your covered drugs from pharmacies not in our plan only when you are unable to get your prescription drugs from a pharmacy that is in our plan. If you live in a long-term care facility, you pay the same as at a standard retail pharmacy.

Stage 3: Coverage Gap

After your total yearly drug costs reach \$5,030, you will receive limited coverage by the plan on certain drugs. You will continue to pay your ICL cost share for Tier 1 preferred generic drugs and Tier 2 generic drugs in the coverage gap. You will pay no more than 25% of the plan's costs for other formulary brand and generic drugs until your yearly out-of-pocket drug costs reach \$8,000.

Stage 4: Catastrophic Coverage

After your yearly out-of-pocket drug costs reach \$8,000, the plan will pay all of your Medicare covered Part D drug costs for the rest of the year.

Our care teams work for you

If you have a chronic condition (diabetes, high blood pressure, heart failure, etc.) or major health issue, our case management team is here for you. This service is included at no extra cost.

Case management includes a team of trained nurses, social workers, therapists, and other medical specialists that can help you:

Plan preventive care.
Learn ways to manage your symptoms.
Find community resources.
Get referrals to other programs we offer
Plan for hospital stays or a procedure

Discharge planning includes a special inpatient team that works with your doctor, so you have the services you need after leaving the hospital.
