- Have Medicare Part B
- Live in the plan's service area, which includes the following counties: **Ohio**: Clark, Clermont, Hamilton, Montgomery, Warren

What you should know

- **Plan type:** Aetna Medicare Premier (HMO-POS) is an HMO plan. This is a Medicare Advantage plan that covers prescription drugs.
- **Primary Care Provider (PCP):** You have the option to choose a PCP. We recommend choosing a PCP because when we know who your provider is we can better support your care.
- **Referrals:** Aetna Medicare Premier (HMO-POS) doesn't require a referral from a PCP to see a specialist. Keep in mind, some providers may require a recommendation or treatment plan from your provider in order to see you.
- Prior authorizations: Your provider will work with us to get approval before you receive certain services or drugs.
