Are you eligible to enroll?

To join Aetna Medicare Prime Chronic Care (HMO C-SNP), you must:

- · Be entitled to Medicare Part A
- Have Medicare Part B
- Live in the plan's service area, which includes the following counties: **Illinois**: Cook, DuPage, Grundy, McHenry, Will
- Must have one of the following qualifying conditions verified by a physician: diabetes mellitus, chronic heart failure, and/or cardiovascular disorders.

What you should know

- **Plan type:** Aetna Medicare Prime Chronic Care (HMO C-SNP) is a CSNP plan. This is a Medicare Advantage plan that covers prescription drugs.
- **Primary Care Provider (PCP):** A PCP is important to help coordinate your care. We require you to select a PCP. When you enroll, we'll ask who your PCP is. If you don't tell us, we'll assign one to you. You can change your PCP anytime by calling us or logging into your member portal.
- **Referrals:** Aetna Medicare Prime Chronic Care (HMO C-SNP) doesn't require a referral from a PCP to see a specialist. Keep in mind, some providers may require a recommendation or treatment plan from your provider in order to see you.
- **Network:** Our plan has a network of select providers to provide you with patient-centered care, coordinated services and enhanced provider communication. To locate a network provider you may contact Member Services or search the online provider directory.
- Prior authorizations: Your provider will work with us to get approval before you receive certain services or drugs.
