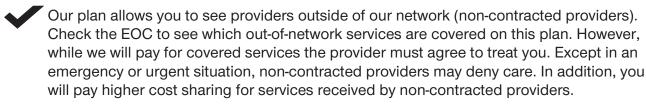




Understanding important rules
