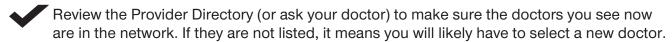








Understanding important rules
