When do I use this form?

You can join a plan:

- Between October 15-December 7 each year (for coverage starting January1)
- Within 3 months of first getting Medicare
- In certain situations where you're allowed to join or switch plans

What do I need to complete this form?

- Your Medicare Number (the number on your red, white, and blue Medicare card)
