Paying Your Plan Premium

You can pay your monthly plan premium (including any late enrollment penalty that you currently have or may owe), by mail or by Electronic Funds Transfer (EFT) each month. You can also choose to pay your premium by automatic deduction from your Social Security or Railroad Retirement Board (RRB) benefit check each month. If you are assessed a Part D-Income Related Monthly Adjustment Amount (Part D-IRMAA), you will be notified by the Social Security Administration. You will be responsible for paying this extra amount in addition to your plan premium. You will either have the amount withheld from your Social Security or RRB benefit check or be billed directly by Medicare. DO NOT pay Blue Cross and Blue Shield of Texas the Part D-IRMAA.

People with limited incomes may qualify for Extra Help to pay for their prescription drug costs. If eligible, Medicare could pay for 75% or more of your drug costs including monthly prescription drug premiums, annual deductibles, and coinsurance. Additionally, those who qualify will not be subject to the coverage gap or a late enrollment penalty. Many people are eligible for these savings and don't even know it. You can also apply for Extra Help online at www.ssa.gov/medicare/part-d-extra-help.

If you qualify for Extra Help with your Medicare prescription drug coverage costs, Medicare will pay all or part of your plan premium. If Medicare pays only a portion of this premium, we will bill you for the amount that Medicare doesn't cover.

By completing this enrollment application, I agree to the following:

Blue Cross Medicare Advantage is a Medicare Advantage plan and has a contract with the federal government. I will need to keep my Medicare Parts A and B to stay in this plan. I can be in only one Medicare Advantage plan at a time, and I understand that my enrollment in this plan will automatically end my enrollment in another Medicare health plan or prescription drug plan. It is my responsibility to inform you of any prescription drug coverage that I have or may get in the future. Enrollment in this plan is generally for the entire year. Once I enroll, I may leave this plan or make changes only at certain times of the year when an enrollment period is available, (Example: Oct. 15 – Dec. 7 of every year), or under certain special circumstances.

Blue Cross Medicare Advantage serves a specific service area. If I move out of the area that Blue Cross Medicare Advantage serves, I need to notify the plan so I can disenroll and find a new plan in my new area. Once I am a member of Blue Cross Medicare Advantage, I have the right to appeal plan decisions about payment or services if I disagree. I will read the Evidence of Coverage document from Blue Cross Medicare Advantage when I get it to know which rules I must follow to get coverage with this Medicare Advantage plan. I understand that people with Medicare aren't usually covered under Medicare while out of the country except for limited coverage near the U.S. border.

I understand that beginning on the date Blue Cross Medicare Advantage coverage begins, I must get all of my medical and prescription drug benefits from this plan. Benefits and services provided by Blue Cross Medicare Advantage and contained in my Blue Cross Medicare Advantage "Evidence of Coverage" document will be covered. Neither Medicare nor Blue Cross Medicare Advantage will pay for benefits or services that are not covered. I understand that using services in-network can cost less than using services out-of-network, except for emergency or urgently needed services or out-of-area dialysis services. If medically necessary, Blue Cross Medicare Advantage provides refunds for all covered benefits, even if I get services out of network. If the service requires prior authorization as stated in the Evidence of Coverage document, neither Medicare nor Blue Cross Medicare Advantage will pay for the services without prior authorization.

I understand that if I am getting assistance from a sales agent, broker, or other individual employed by or contracted with Blue Cross Medicare Advantage, he/she may be paid based on my enrollment in Blue Cross Medicare Advantage.
